Section 5. Fire-fighting measures

Section 7. Handling and storage

Precautions for safe handling

Use a suitable hand truck for cylinder movement. Avoid contact with eyes, skin and clothing. Empty containers retain product residue and can be hazardous.
- Advice on general occupational hygiene** : Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed.
